Community Emergency Response Team Volunteering: Becoming a trained ally to act effectively and safely in local, state, and federal disaster mitigation and response

Disaster situations and recovery often become a catalyst for people wanting to offer their help. Without proper training in aspects such as basic disaster response, operations, disaster psychology, fire safety, and search and rescue, well-intended volunteers can quickly become a liability and risk, more than an aid to the situation or those who are responding to it. Community emergency Response Team (CERT) trained volunteers work as a team, are deployable by emergency officials, and have been widely recognized as valued contributors in both non-emergency and disaster situations. In this session, The Ferguson team will discuss the CERT program, explore the basic CERT training module, and emphasize the many ways in which CERT volunteer teams and their trained members serve as a valuable support.

ADvancing States supports visionary leadership, the advancement of systems innovation and the articulation of national policies that support long term services and supports for older adults and people with disabilities. The primary purposes of ADvancing States are to serve as a focal point of communication between the states and the federal government and to provide an information network among the states on long-term services and supports. Ms. Roherty and her staff are responsible for educating Congress, the Administration, other state executive branch organizations, advocacy groups, and the general public on administrative and health and social policy issues of special concern to the state officials administering the programs for long-term care services. Ms. Roherty also furnishes technical assistance to state Aging, Medicaid, and Disability program staff, including the development of competencies in the transition to person-centered planning, options counseling, and self-direction. Ms. Roherty currently serves on various Boards of leadership: the National Resource Center for Participant Directed Services; the National Academy of Social Insurance; the National EVV Association; the Center for Excellence in Assisted Living; and the Long-Term Quality Alliance. She holds a Master of Public Policy with a concentration in finance from the University of Maryland. Ms. Roherty is the mother of 5, including an adult son with autism who is on the Medicaid waiver, and annually participates in his own person-centered planning process.
